Dear Kiwanians,

The California-Nevada-Hawaii District provides each Lt. Governor a budget to help offset the cost of your office. You will be able to vouch for expenses incurred between October 1, 2019 and September 30, 2020.

In order for us to prepare your budget, it is necessary for you complete the attached form and submit it to the District office as soon as possible.

## PLEASE NOTE WE ARE ASKING FOR **ONE-WAY** MILEAGE ONLY.

Compute your mileage from your home club meeting place. We will calculate the round trip mileage for your budget.

You will receive a mileage allowance to attend the Mid-Year Conference <u>closest</u> to the division you serve. Again, please indicate your mileage to the events requested as **one-way mileage only**.

You will receive a travel allowance for the 2020 International Convention. This will come from a fund maintained exclusively for officer's travel to the International Convention. The District Board will approve the amount of this allowance at an upcoming Board meeting.

There is no provision in our Bylaws for you, as the Lt. Governor-designate, to be paid for attending the 2019 District Convention in Las Vegas, NV this August. You will, however, be asked to be available for your installation on Saturday, August 17, 2019. Again, you will be eligible for reimbursement for expenses incurred after October 1, 2019.
