Dear Kiwanians,

The California-Nevada-Hawaii District provides each Lt. Governor with a budget to help offset the cost of your office. You will be able to vouch for travel expenses incurred and completed between October 1, 2022 and September 30, 2023.

In order for us to prepare your budget, it is necessary for you to complete the attached form and submit it to the District office as soon as possible. THIS BUDGET WILL BE APPROVED BY THE DISTRICT BOARD OF TRUSTEES. LT. GOVERNORS WITHOUT AN APPROVED BUDGET WILL NOT BE ABLE TO VOUCH FOR REIMBURSEMENT OF EXPENSES.

## PLEASE NOTE WE ARE ASKING FOR ONE-WAY MILEAGE ONLY.

- Compute your mileage from your <u>home club meeting place</u>. We will calculate the round-trip mileage for your budget.
- You will receive a mileage allowance to attend one of the Mid-Year Conferences <u>closest</u> to the division you serve. Again, please indicate your mileage to the events requested as <u>one-way mileage only</u>.
- You will receive a travel allowance for the 2023 International Convention in Minneapolis,
  Minnesota. This will come from a fund maintained exclusively for officers' travel to the
  International Convention. The District Board will approve the amount of this allowance
  at an upcoming Board meeting.

**PLEASE NOTE:** There is no provision in our Bylaws for you, as the Lt. Governor-designate, to be paid for attending the 2022 District Convention in Indian Wells, CA this August. You will, however, be asked to be available for your installation on Saturday night, August 6, 2022. Again, you will be eligible for reimbursement for expenses incurred after completion and starting October 1, 2022.
