Thank you again for the opportunity! Below is our offering. I look forward to your feedback. We would be excited to have the Kiwanis back!

To briefly re-cap the recent renovations, we completed renovations in the Conference Center last year to include new vinyl, fixtures, and furniture in foyer that includes large communal tables that include charging stations.

The Irish Pub was absorbed into the renovations for the new race & sports book. Starbucks moved to be next to Cascade and is larger with outdoor seating. The Clubhouse Deli is now where Starbucks used to be. Edge Lounge was gutted and renovated and is now Cascade.

We are happy to offer availability at a rate of \$129 per night for August 14-18 or August 2-25, 2019. We will discount the resort fee to \$21.99 per night for this group.

This room rate does not include a taxable Resort Fee, currently \$25.99 per room per night. The Resort Fee package includes Guestroom High Speed Internet Access; Local, 800 and Domestic Long Distance guest room telephone calls, access to Spa Aquae Fitness and Wellness Center, two (2) small bottles of water in guest room refreshed daily, two (2) drink coupons in the Rampart Casino and one (1) glass of house wine with meal purchase at the Hawthorn Grill.

SPECIAL CONCESSIONS

In consideration of the Room Night Commitment and the functions identified on the Function Information Agenda/Event Agenda, Hotel will provide Kiwanis California-Nevada-Hawaii District with the following special concessions:

1. One (1) complimentary sleeping room for every forty (40) full revenue generating sleeping rooms on a cumulative basis to be utilized during your program.
2. With the given room night commitment and function agenda, the meeting and meal space is complimentary with 80% pick up of the room night commitment and a catering minimum of \$60,000 (exclusive of service charge and applicable taxes) is achieved.
3. One (1) complimentary Presidential Suite (Two-Bedroom Suite) Over contracted program dates.
4. One (1) Complimentary One-Bedroom Suite over program dates, and one (1) One-Bedroom Suite at the group rate.
5. Ten (10) upgrades to One-Bedroom Suites at the group rate for VIP upgrades
6. Ten (10) complimentary welcome amenities valued at \$50.00 each and at the Resort's discretion.

14. Complimentary shuttle service to/from the Strip. This is a 29-passenger van and is available on a first-come-first serve basis.

Below is the function space we are offering. This is based on what they contracted last time. Please let me know if the agenda and requirements have changed much from this.

The spaces highlighted in blue are spaces that no longer are available for sale. Marbella is going to be a Chinese restaurant, and Parian is now meeting space. The Edge Lounge was completely gutted and renovated and is called Cascade now. The space has much more functionality and can hold up to 325-350 in rounds. This space can replace function that we had in Marbella or perhaps be used for exhibits instead of Valencia. There is some opportunity to shuffle some things around.

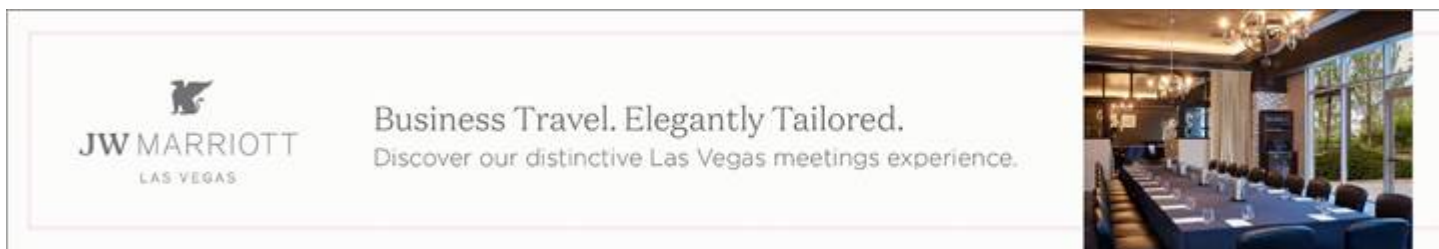
